ORDINANCE: 1543

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON,
REVISING 1990 PAY RATES FOR COMMUNICATIONS
DISPATCHERS

WHEREAS, the City of Redmond agreed through the collective bargaining process to modify the work schedule in 1990 for Communications Dispatchers; and,

WHEREAS, the parties agreed to reduce Dispatcher pay rates in 1990 to offset the effect of the federal Fair Labor Standards Act on employee compensation unintentionally occurring as a result of the new schedules; now, therefore

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO
ORDAIN AS FOLLOWS:

Section 1. "Pay Plan C-1 -- Police Support Bargaining Unit," adopted by Ordinance Number 1538 is hereby amended, reducing by 3.5% the 1990 pay rates previously established for Communications Dispatchers, as set forth in Exhibit A attached hereto and incorporated by this reference as if set forth in full.

Section 2. The change to Pay Plan C-1 effectuated by this ordinance shall be effective as of 1 January 1990.

Section 3. This ordinance, being an administrative action, is not subject to referendum and shall take effect five days after its publication, or publication of a summary thereof, in the City's official newspaper.
