ORDINANCE NO. 1552

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON,
ADDING A NEW SECTION 13.36.030 TO THE REDMOND
MUNICIPAL CODE ESTABLISHING AN APPLICATION
PROCESS FOR REQUESTS FOR THE EXTENSION OF UTILITY
SERVICE OUTSIDE THE CITY LIMITS.

WHEREAS, Ordinance No. 1437, passed by the City Council on July 5, 1988, added Chapter 13.36 to the Redmond Municipal Code in order to set forth the conditions for extension of water, sanitary sewer and storm drainage service outside the City limits, and

WHEREAS, the City of Redmond is receiving requests to provide extensions of utility service outside the City limits and desires to establish the method of application and the information required for the City to make its decision on whether such requests should be granted, and

WHEREAS, considerable time is spent by the City staff in reviewing and processing requests for extension and the City Council has determined that an application fee should be set accordingly, and

WHEREAS, in order to be consistent with other application fees set by the City, the Council has determined to provide that the application fee will be set by Resolution, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON,
HEREBY ORDAINS AS FOLLOWS:

Section 1. Applications for Extension of Utility

Service. A new Section 13.36.030 is hereby added to the Redmond Municipal Code to read as follows:

13.36.030 Application.

- A. Any person desiring to apply for the extension of water, sanitary sewer or storm drainage service outside the City limits under the provisions of this Chapter shall do so on a form provided by the City. The completed application form, together with a nonrefundable application fee set by Council Resolution, shall be submitted to the Public Works Department, and accompanied by the following:
1. A vicinity map on 8-1/2 x 11 inch mylar, drawn to a scale acceptable to the Public Works Department, depicting the area for which service is being requested and the existing City facilities from which the extension is proposed to be made; and
 2. A legal description of the property to be served by the extension; and
 3. A statement of the nature of the proposed development and its conformance with the requirements of the City's comprehensive plan, zoning code and building regulations; and
 4. Such other information as the Director of Public Works determines is necessary to properly review the application.
- B. The Public Works Department shall review the application and forward the same, together with the Department's recommendation, to the City Council for determination.

Section 2. Severability. If any section, sentence, clause or phrase of this ordinance shall be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 3. Effective Date. This ordinance, being an exercise of a power specifically delegated to the City legislative body, is not subject to referendum, and shall take effect five (5) days after passage and publication of the attached summary which is hereby approved.
