

RESOLUTION NO. 162

A RESOLUTION, relating to animal control and authorizing the execution of an agreement with the King County Humane Society.


WHEREAS, the King County Humane Society is now equipped to handle matters relating to animal control in King County east of Lake Washington and is willing to render such service to the City of Redmond as its agent for an agreed consideration; and the City Council finds it is in the public interest to enter into an agreement for such purposes; NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF REDMOND, as follows:

1. That the King County Humane Society be designated as agent for the City of Redmond in matters relating to animal control pursuant to the terms of the attached Agreement.
2. That the Mayor and City Clerk be authorized and empowered to execute the original and copies of the attached Agreement on behalf of the City of Redmond.

PASSED by the Council of the City of Redmond, Washington at a regular meeting thereof, and APPROVED by the Mayor this 24<sup>th</sup> day of May, 1966.

A G R E E M E N T

THIS AGREEMENT is made as of the 24<sup>th</sup> day of May, 1966, by and between the CITY OF REDMOND, a municipal corporation of the State of Washington, herein called City, and KING COUNTY HUMANE SOCIETY, a Washington non-profit corporation, herein called Society, WITNESSETH:

1. The Society at the request of the Police Department of the City, agrees to provide truck, driver and necessary equipment and patrol for the City for the purposes of:

- a. Removing dead animals;
- b. Caring for and/or removing injured, diseased or infected animals;
- c. Picking up and impounding stray and/or dangerous animals;
- d. Answering complaints regarding animals received from the City Police Department;
- e. Selling dog licenses..

2. The City shall pay to the Society, upon receipt of monthly billing, the sum of \$4.50 per hour or call. The Society shall remit to the City Treasurer all receipts from the sale of dog licenses.

3. The Society shall act as the agent of the City in the enforcement of ordinances of the City relating to dog and animal control now in force or as may be adopted or amended.

4. The Society shall act as poundmaster for the City and shall provide pound services for the City and its residents and make reasonable charges therefor directly to the owners of the animals involved. The Society is authorized to destroy any animal unclaimed or unredeemed after seventy-two (72) hours of confinement by the Society. The Society shall retain all impound fees and boarding fees.

5. This Agreement shall continue in effect from the date hereof until terminated by either party upon thirty (30) days

written notice.
