Amend RMC 5.36 - Music Box Licensing

ORDINANCE NO. 1624

ORIGINAL

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING SECTION 5.36.050 AND REPEALING SECTION 5.36.070 OF THE REDMOND MUNICIPAL CODE RELATING TO MUSIC BOX LICENSING.

WHEREAS, section 5.36.070 of the Redmond Municipal Code currently requires that the City provide, upon issuance of a music box license, a tag to the licensee to be displayed upon any music box maintained or operated within the City, and

WHEREAS, to the best of the City Clerk's knowledge, the City has never provided such a license tag, and the City Clerk's office has proposed that the licensee display a copy of the music box license as an alternative method to identify a music box which has been properly licensed pursuant to Chapter 5.36 of the Redmond Municipal Code, and

WHEREAS, the City Council has determined that this alternative method effectively identifies licensed music boxes, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, HEREBY ORDAINS AS FOLLOWS:

Section 1. Amendment. Section 5.36.050 of the Redmond Municipal Code is hereby amended to read as follows:

5.36.050 Issuance - Term. Upon approval of the application by the City Clerk or other designated officer, the City Clerk's office shall compute the license fee required under the provisions of this chapter and, upon payment thereof, shall issue to the applicant a license to maintain and operate music boxes for the calendar year in which issued. The license

shall be known as a "Music Box License" and shall be of two kinds: (1) a "master" license to be required of the owner of the music box(es) and (2) an "operator's" license to be required of the owner of the business establishment in which the music box is placed.

A copy of the operator's license shall be affixed to and conspicuously displayed upon each properly licensed music box maintained or operated within the City. No owner or operator of a properly licensed music box shall transfer said license from one music box to another, and no properly licensed music box shall be transfered from one location to another except with the consent of the City Clerk's office.

Each license shall expire at the end of the calendar year in which it is issued, and a new license shall be required for each ensuing calendar year. Any license issued under and by virtue of the provisions of this chapter shall be personal and nontransferable. Each license shall be numbered, and shall show the name of the licensee, business address and the kind of license issued.

Section 2. Repealed. Section 5.36.070 of the Redmond Municipal Code is hereby repealed.

Section 3. Effective Date. This ordinance, being an exercise of a power specifically delegated to the City legislative body, is not subject to referendum, and shall take effect five (5) days after passage and publication of the ordinance or a summary thereof consisting of the title.
