RESOLUTION NO. 164 A RESOLUTION, calling for an election to be held on the annexation of certain unincorporated territory to the City of Redmond, Washington. WHEREAS, the City Council has determined that the best interests and general welfare of the City of Redmond and the residents concerned would be served by the annexation of the territory described below to the City of Redmond and that such annexation would make possible necessary municipal services to such territory and would reduce irregular boundaries and serve to eliminate isolated pockets of unincorporated territory contiguous to the City, Now, Therefore, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF REDMOND: 1. That the City Council does hereby determine that the best interests and general welfare of the City of Redmond would be served by the annexation of the unincorporated territory described below, which lies outside of the present limits of the City and is contiguous thereto: Beginning at the intersection of the easterly right-of-way margin of 148th Ave. N.E. and the east-west centerline of Section 14, Township 25 North, Range 5 East, W.M.; Thence easterly along said east-west centerline to its inter-section with the west line of Lot 16, East Side Gardens, as recorded in volume 12 of plats, page 68, records of King County, Washington; Thence northerly along said west line of Lot 16 to its intersection with the southerly right-of-way margin of N.E. 51st Street (AKA Tosh Road #113); Thence easterly along said southerly margin to its intersection with the southerly extension of the westerly line of Lot 8 of said plat; Thence northerly along said southerly extension and the westerly line of Lot 8 and the westerly line of Lot 5 of said plat to its intersection with the southerly right-of-way margin of N.E. 60th Street (AKA County Road #1690); Thence westerly along said southerly right-of-way margin to its intersection with the easterly right-of-way margin of 148b Ave. N.E.; Thence northerly along said easterly right-of-way margin to a point 30 feet easterly of, measured at right angles, the intersection of the east line of the southeast quarter of Section 10, Township 25 North, Range 5 East, W.M., and a line 539.50 feet north of and parallel with the south line of said southeast quarter of Section 10; Thence westerly 30 feet, measured at right angles, to said intersection; Thence westerly along a line 539.50 feet north of and parallel to the south line of said southeast quarter of Section 10 a distance of 1335 feet; Thence northerly and parallel to the east line of said south-east quarter of Section 10 to the north line of the south half of said southeast quarter of Section 10; Thence westerly along said north line to a point which lies 1023.27 feet east of the northwest corner of said south half of the southeast quarter of Section 10; Thence northerly and parallel to the west line of said south-east quarter of Section 10 to the northerly margin of State -1-164

Aid Road No. 4 (AKA Collins Road No. 850 and Old Redmond Road); Thence continuing northerly 568.0 feet more or less to the south line of the north half of said Section 10 at a point 1493.73 feet westerly from the northeast corner of said southeast quarter of Section 10; Thence westerly along said south line to an intersection with a line 334 feet easterly of and parallel with the west line of said southeast quarter of Section 10; Thence southerly along said parallel line to an intersection with the northerly right-of-way margin of State Aid Road No. 4 (AKA Collins Road No. 850); Thence westerly along said northerly margin to an intersection with the west line of said southeast quarter of Section 10; said west line being the centerline of 140.4 Ave. N.E.; Thence southerly along said centerline to an intersection with the westerly extension of the north line of the south 170 feet of the north half of the north third of the northwest quarter of the southeast quarter of Section 15; Township 25 North, Range 5 East. W.M.: Thence easterly along said north line to an intersection with the west line of the northeast quarter of said southeast quarter of Section 15; Thence southerly along said west line to the south line of the north one quarter of said northeast quarter of the southeast quarter of Section 15; Thence easterly along said south line and the easterly extension thereof to an intersection with the easterly rightof-way margin of 148th Ave. N.E.; Thence northerly along said easterly margin to an intersection with the east-west centerline of said Section 14 and the point of beginning; Situated in King County, Washington. 2. That, as nearly as may be, the number of voters residing in the territory described above is 35. 3. That the City Council hereby prays that the Board of County Commissioners of King County, Washington, call an election to be held among the qualified voters in the territory described above upon the question of annexation pursuant to Chapter 35.13 RCW. 4. That the cost of the annexation election shall be paid by the City of Redmond. 5. That there shall also be submitted to the electorate of such territory a proposition that all property within the area annexed shall, upon annexation, be assessed and taxed at the same rate and on the same basis as the property of the City of Redmond is assessed and taxed to pay for any then outstanding indebtedness of the City of Redmond, contracted prior to, or existing at, the date of annexation. That a certified copy of this Resolution be filed immediately with the Board of County Commissioners of King County, -2-164 Washington, in which county the above described territory is located.
