AN ORDINANCE OF THE CITY OF REDMOND,
WASHINGTON, AMENDING CHAPTER 5.60 OF
THE REDMOND MUNICIPAL CODE TO UPDATE
THE LIST OF CITY-OWNED AND MAINTAINED
BUILDINGS AND PUBLIC SCHOOLS LOCATED
IN THE CITY OF REDMOND.

WHEREAS, the City Clerk has reviewed APPENDIX "A"
of Chapter 5.60 of the Redmond Municipal Code and has
determined that the listing of City-owned and maintained
buildings and the listing of Lake Washington School District
public schools located in the City of Redmond is outdated
and in need of revision, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND,
WASHINGTON, HEREBY ORDAINS AS FOLLOWS:


