ORDINANCE NO. 1699

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON  
ANNEXING A PORTION OF THE 95TH STREET RIGHT-OF-WAY  
EAST OF AVONDALE ROAD

---

WHEREAS, the City of Redmond's northern boundary east of a line approximately 750' east of the Avondale Road center line is the south line of the 95th Street right-of-way, and

WHEREAS, the City Council has determined that it would be in the best interest of the City to assume jurisdiction over 95th Street and extend the City's northern boundary to the north right-of-way line, and

WHEREAS, RCW 35.21.790 permits the governing bodies of counties and cities to revise, by agreement, any part of the corporate boundary of the city which coincides with the edge of a public street or right-of-way, and provides that such boundary revision becomes effective when approved by ordinance of the City Council and by ordinance or resolution of the County Council, and

WHEREAS, King County has passed an ordinance approving the annexation and boundary revision and requesting that the City do the same, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON,  
HEREBY ORDAINS AS FOLLOWS:


Section 1. Annexation and Boundary Revision. Pursuant to RCW 35.21.790, the corporate boundary of the City of Redmond is hereby revised to include the right-of-way legally described on Exhibit A attached hereto and incorporated herein by this reference as if set forth in full, and to annex the same to the City.

Section 2. Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent

jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

**Section 3. Effective Date.** This ordinance, being an exercise of a power specifically delegated to the City legislative body, is not subject to referendum, and shall take effect five (5) days after passage and publication of the ordinance or a summary thereof consisting of the title.

FOR  
95TH STREET ANNEXATION

All of NE 95th Street (also known as Conrad Olsen Rd. No. 1427, Survey No. 1730a Est. 1-27-1930, Co. Comm. Vol330-212) lying between the Easterly line of that area described in Redmond Ordinance 1631 as annexed to said City and ending at the northerly extension of the east line of the west half of the southwest quarter of the northeast quarter of Section 6, Township 25 North, Range 6 East.
