ORDINANCE NO. 1727

ORIGINAL

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING SECTION 13.18.050(B) OF THE REDMOND MUNICIPAL CODE TO INCREASE THE BASE RATE FOR MONTHLY STORM WATER UTILITY SERVICE FROM \$3.00 PER IMPERVIOUS UNIT TO \$6.00 PER IMPERVIOUS UNIT, AND ESTABLISHING AN EFFECTIVE DATE FOR SUCH RATE INCREASE.

WHEREAS, water quality is an important environmental concern for all citizens of the City of Redmond, and

WHEREAS, storm water management is a vital component in any water quality program, and

WHEREAS, a study has been conducted with regard to storm water utility rates in order to determine the proper base rate to provide sufficient revenue for capital programs, maintenance and operating reserves, and the implementation of a city wide comprehensive water quality program, and

WHEREAS, based upon the results of the study, the Storm Water Division of the City's Public Works Department has recommended that the storm water utility base rate be increased from \$3.00 per impervious unit (IU) to \$6.00 per IU and,

WHEREAS, the City Council concurs that the increase is necessary to provide funding for the projects to be completed by the utility, NOW, THEREFORE,


THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO
ORDAIN AS FOLLOWS:

Section 1. Section 13.18.050(B) of the Redmond Municipal Code is hereby amended to read as follows:

B. Single Family Parcels. The monthly service charge for each single-family parcel shall be \$6.00, which shall hereafter be referred to as the "base rate."

Section 3. Effective Date. This ordinance shall take effect and be in full force on and after June 1, 1993, and the storm water utility base rate set forth in Section 1 shall apply to all monthly service charges for which a bill is sent to the customer after that date. The City Clerk shall publish the attached summary of this ordinance, which is hereby approved.


