ORDINANCE NO. 1774

AN ORDINANCE OF THE CITY OF REDMOND,  
WASHINGTON, AMENDING SECTION 9.44.060 OF  
REDMOND MUNICIPAL CODE PERTAINING TO PENALTY  
FOR VIOLATION OF ABATEMENT OF NUISANCE AND  
ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, Ordinance No. 1244, adopted on April 2, 1985,  
resulted in several changes to the City Criminal Code including  
those provisions dealing with penalties, and

WHEREAS, Section 9.44.060 of the Redmond Municipal Code  
needs to be updated in order to reflect the changes to the penalty  
provisions that were made by Ordinance 1244, NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON,  
HEREBY ORDAINS AS FOLLOWS:


Section 1. Penalty for Violation--Abatement of Nuisance.

Section 9.44.060 of the Redmond Municipal Code is hereby amended to  
read as follows:


9.44.060 Penalty for Violation--Abatement of  
Nuisance. Any person violating or failing to  
comply with any of the provisions of the  
Ordinance codified in this chapter shall be  
guilty of a misdemeanor and, upon conviction  
thereof, shall be punished as provided in  
Section 9.01.050 of this Code. In addition,  
the court may order such nuisance abated by  
causing removal of such junk, either by the  
defendant or other person or by the use of  
city employees at the defendant's expense, or  
such nuisance may be abated as provided by  
law.

Section 2. Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 3. Effective Date. This ordinance, being an exercise of a power specifically delegated to the City legislative body, is not subject to referendum, and shall take effect five (5) days after passage and publication of an approved summary thereof consisting of the title.
