Revise Speed Limit on  
154 Place NE

ORDINANCE NO. 1783

ORIGINAL

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING THE SCHEDULE OF SPEED LIMITS ADOPTED BY SECTION 10.24.060 OF THE REDMOND MUNICIPAL CODE IN ORDER TO ESTABLISH A 30 M.P.H SPEED LIMIT ON 154TH PLACE N.E. BETWEEN REDMOND - WOODINVILLE ROAD (SR 202) AND THE NORTH CITY LIMITS.

WHEREAS, the City's Traffic Engineer has recommended that a 30 m.p.h. speed limit be established on 154th Place N.E. between Redmond - Woodinville Road (SR 202) and the north City limits, and

WHEREAS, the City Council concurs with the Traffic Engineer's recommendation, NOW, THEREFORE,


THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO  
ORDAIN AS FOLLOWS:

Section 1. Speed Limit. A 30 m.p.h. speed limit is hereby established for 154th Place N.E., both ways, from the Redmond - Woodinville Road (SR 202) to the north City limits, and the schedule of speed limits adopted by Section 10.24.060 of the Redmond Municipal Code is hereby amended to add the following line:

State Route No./City Street Designation	Traffic Direction	From	To	Maximum Speed
154th Place N.E.	Both ways	Redmond - Woodinville Road (SR 202)	North City limits	30 m.p.h.

Section 2. Effective Date. This ordinance, being an exercise of a power specifically delegated to the City legislative body, is not subject to referendum, and shall take effect five (5) days after passage and publication of an approved summary thereof consisting of the title, provided, that the police department shall enforce the speed limit provided in Section 1 of this Ordinance only after the posting of appropriate signs meeting the approval of the Traffic Engineer indicating the speed limit so adopted.
