ORDINANCE NO. 1805

ORIGINAL

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, REPEALING REDMOND MUNICIPAL CODE SECTIONS 13.04.050, 13.04.060, 13.04.070, 13.04.080, 13.04.090 AND 13.04.100; CREATING A NEW CHAPTER 13.05, SIDE SEWER CONTRACTOR ROSTER AND AMENDING SECTION 13.04.020(12) DEFINING SIDE SEWER CONTRACTOR.

WHEREAS, Ordinance 210 which was adopted in 1958 created a process and procedure for a side sewer contractors license, and

WHEREAS, the part of the Code that deals with side sewer contractors has not been updated to reflect the changes and procedures which have occurred, and

WHEREAS, it is appropriate to establish new procedure for regulating side sewer contractors, NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO  
ORDAIN AS FOLLOWS:

Section 1. Repealing Certain Sections of Chapter 13.04. Sections 13.04.050, 13.04.060, 13.04.070, 13.04.080, 13.04.090 and 13.04.100 of the Redmond Municipal Code are hereby repealed.

Section 2. Side Sewer Contractor Roster. The Redmond Municipal Code is hereby amended by the addition of a new Chapter 13.05 entitled Side Sewer Contractor Roster to read as follows:

Chapter 13.05  
Side Sewer Contractor Roster

Section 13.05.010. Purpose. The purpose of this chapter is to regulate those persons authorized to perform work on side sewers within the public right-of-way and on private property in order to protect the sewer system from defective workmanship and materials, and to insure that the construction standards and the regulations of the City are followed.

Section 13.05.020. Side Sewer Contractor Roster. A Side Sewer Contractor Roster is hereby established which shall be maintained by the Utility Division of the Public Works Department which shall contain the names of those contractors which are approved to perform work on side sewers.

Section 13.05.030. Violation. It is a violation of the Redmond Municipal Code for any person to make any connection to any public sewer, or to construct, alter, or repair any private sewer unless the person is an active contractor on the Side Sewer Contractor Roster, provided that a homeowner, who is not a contractor by trade, may make repairs to his/her side sewer if the repair is totally within the property of the homeowner.

Section 13.05.040. Application. All persons desiring to be included on the Side Sewer Contractor Roster are required to make application, pay an application fee, and pay the first year's annual roster fee to the Utility Division of the Public Works Department. The application shall be reviewed by the Utility Division to determine if the contractor has sufficient knowledge and experience to carry on the business of a side sewer contractor, and is skilled in the laying and construction of side sewers. The information required in Section 13.05.050 of this chapter shall also be submitted with the application.

13.05.050. Side Sewer Contractor Roster Eligibility Requirements. The following requirements must be met in order to remain an active contractor on the Side Sewer Contractor Roster:

- A. A City of Redmond business license.
- B. A State of Washington contractor's registration

- C. Proof of liability insurance.
- D. A side sewer contractor's bond.
- E. Annual roster fee.

Should any of the above requirements not be met, the contractor shall be designated an inactive contractor on the Side Sewer Contractor Roster. Should any contractor remain so designated for more than twelve (12) months the contractor shall be removed from the roster and a new application and fee will be required to re-instate the contractor.

13.05.060. Side Sewer Contractor Bond. Every side sewer contractor shall file with the Utility Division a bond in a form approved by the City in the amount of \$5,000.

13.05.070. Insurance. The contractor shall provide proof of liability insurance in the amount of \$500,000 naming the City as an additional insured.

13.05.080. Annual Roster Fee and Application Fee. The annual Side Sewer Contractor Roster fee and the application fee shall be set by Council resolution. The annual fee shall be for each calendar year period.

13.05.090. Removal from Roster. A contractor may be removed from the Side Sewer Contractor Roster for any of the following causes: failure to observe the laws and regulations of the City; failure to pay for labor or material used in the construction of a side sewer; fraud or misrepresentation to the owner, agent or occupant of a building for the purpose of obtaining a contract for the construction of a side sewer; or for nonpayment for work performed by the City for which a side sewer contractor may be liable.

Section 3. Side Sewer Contractor Definition. Redmond Municipal Code Section

13.04.020(12) is hereby amended to read as follows:

- 12. "Side Sewer Contractor" means a contractor approved by the City to construct or repair side sewers and who is on the active Side Sewer Contractor Roster.

Section 4. Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 3. Effective Date. This ordinance, being an exercise of a power specifically delegated to the City legislative body, is not subject to referendum, and shall take effect five (5) days after passage and publication of an approved summary thereof consisting of the title.


