ORDINANCE NO. 1827

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING SECTION 4 OF ORDINANCE NO. 1722 IN ORDER TO DELETE THE SUNSET PROVISION CONTAINED THEREIN AND TO EXTEND THE CITY'S COMMUTE TRIP REDUCTION REGULATIONS INDEFINITELY BEYOND MARCH 16, 1995.

WHEREAS, Ordinance No. 1722 of the City of Redmond establishes the City's Commute Trip Reduction (CTR) regulations as Chapter 5.64 of the Redmond Municipal Code, as required by RCW 70.94.527, and

WHEREAS, Section 4 of Ordinance No. 1722 provides for the automatic sunset and repeal of the CTR regulations and Chapter 5.64 on March 16, 1995 unless further action is taken by the City Council, and

WHEREAS, the purpose of the sunset clause was to ensure that the need for and content of the regulations would be revisited before March 16, 1995, and

WHEREAS, RCW 70.94.527 remains in effect and the City is therefore required to extend the CTR regulations and, after reviewing the same, the City Council has determined to extend the regulations in their current form indefinitely, NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, HEREBY ORDAIN AS FOLLOWS:

Section 1. Amendment of Ordinance No. 1722 and Extension of Regulations. Section 4 of Ordinance No. 1722 of the City of Redmond, passed by the City Council on March 16, 1994, is hereby amended to remove the automatic repeal and sunset clause, to extend the CTR regulations contained within Chapter 5.64 of the Redmond Code indefinitely, and to read as follows:

Section 4 Effective Date. This ordinance, being an exercise of a power specifically delegated to the City legislative body, is not subject to referendum, and shall take effect five (5) days after passage and publication of the attached summary, which is hereby approved. The regulations adopted by this ordinance as Chapter 5.64 of the Redmond Municipal Code shall remain in effect indefinitely unless further action is taken by the City Council.

Section 2. Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 3. Effective Date. This ordinance, being an exercise of a power specifically delegated to the City legislative body, is not subject to referendum, and shall take effect five (5) days after publication of the attached summary, which is hereby approved.
