AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, SETTING 1995 AND 1996 PAY RATES FOR POLICE OFFICERS AND SERGEANTS REPRESENTED BY THE REDMOND POLICE OFFICERS ASSOCIATION COLLECTIVE BARGAINING UNIT.

WHEREAS, the City of Redmond agreed through the collective bargaining process to grant across-the-board increases in salaries for 1995 and 1996 to commissioned police officers and sergeants represented by the Redmond Police Officers Association and these increases should be reflected by amending Pay Plan C - RPOA, NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. "Pay Plan C - RPOA", covering police officers and sergeants represented by the Redmond Police Officers Association Bargaining Unit is hereby amended by granting a three percent (3.0%) across-the-board increase in 1995 pay rates over rates of pay in effect 31 December 1994 as adopted by Ordinance 1755 as set forth in Exhibit A attached hereto and incorporated by this reference as if set forth in full.

Section 2. "Pay Plan C - RPOA", covering police officers and sergeants represented by the Redmond Police Officers Association Bargaining Unit is hereby amended by

granting a three percent (3.0%) across-the-board increase in 1996 pay rates over rates of pay in effect 31 December 1995 as adopted by this ordinance as set forth in Exhibit B attached hereto and incorporated by this reference as if set forth in full.

This ordinance, being Section 3. administrative action, is not subject to referendum and shall take effect five days after its publication, or publication of summary thereof, in the City's official newspaper.
