ORDINANCE NO: 1888

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, MAKING ADJUSTMENTS TO CITY BUDGETS, AMENDING ORDINANCE 1861.

WHEREAS, the Finance Director has identified the need to make certain revisions to the 1996 City budget, and the City Council has reviewed the proposed adjustments and has determined that they should be made, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, HEREBY ORDAINS AS FOLLOWS:

Section 1. Ordinance No. 1861 adopting the 1996 budget, passed by the City Council on November 21, 1995, is hereby amended by revising Exhibit A of Ordinance No. 1861, and to reflect the increased appropriations set forth in Exhibit 1 attached hereto and incorporated herein by this reference as if set forth in full. The sources of funds increased appropriations for the are and overcollections, development underexpenditures grant monies, interfund transfers, and private contributions.

Section 2. Effective Date. This ordinance, being an administrative action, is not subject to referendum and shall take effect five (5) days after passage and publication of an approved summary thereof consisting of the title.
