

**ORDINANCE NO: 1916**

**ORIGINAL**

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, MAKING ADJUSTMENTS TO CITY BUDGETS, AMENDING ORDINANCE NOS. 1861, 1888, 1900, and 1912.

WHEREAS, the Finance Director has identified the need to make certain revisions to the 1996 City budget, and the City Council has reviewed the proposed adjustments and has determined that they should be made, NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Ordinance No. 1861, as amended by Ordinance Nos. 1888, 1900, and 1912, adopting the 1996 budget and supplemental appropriations, is hereby amended by revising Exhibit 1 of Ordinance No. 1861, to reflect the increased appropriations set forth in Exhibit 1 attached hereto and incorporated herein by this reference as if set forth in full. The sources of funds for the increased appropriations are gas tax, building plan check fees, and an interfund transfer to the General Fund.

Section 2. This ordinance, being an administrative action, is not subject to referendum and shall take effect five (5) days after passage and publication of an approved summary thereof consisting of the title.


