

ORDINANCE NO. 1944

ORIGINAL

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING SECTION 1 OF ORDINANCE 1638 IN ORDER TO INCREASE THE SALARY OF REDMOND CITY COUNCIL MEMBERS TO \$ 800 PER MONTH EFFECTIVE JANUARY 1, 2000.

WHEREAS, Ordinance 1638 of the City of Redmond, passed by the City Council on June 18, 1991, established the salary to be paid to Redmond City Council members at \$600.00 per month, effective January 1, 1994, and

WHEREAS, the Council has determined that an increase is in order, and

WHEREAS, in order to insure that no Council member votes on increasing the salary during his or her term of office, the Council has determined to make the increase effective January 1, 2000, after the current terms of all Council members have expired, NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Increase in Salaries. Section 1 of Ordinance 1638 of the City of Redmond is hereby amended to read as follows:

Section 1. Council Salaries. The salary to be paid to Redmond City Council members shall continue at the current level of \$600.00 per month until January 1, 2000, at which time the salary shall be increased to \$ 800 per month.

Section 2. Effect on Remainder of Ordinance 1638. Except as expressly amended above, all remaining provisions of Ordinance 1638 relating to benefits and deferred compensation shall remain unchanged by this ordinance.

Section 3. Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent

jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 4. Effective Date. This ordinance, being an exercise of a power specifically delegated to the City legislative body, is not subject to referendum, and shall take effect five (5) days after passage and publication of an approved summary thereof consisting of the title.
