ORDINANCE NO. 1983

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING CHAPTER 13.21 OF THE REDMOND MUNICIPAL CODE IN ORDER TO AUTHORIZE STORM WATER ENGINEERING, PLAN REVIEW, AND PROCESSING FEES TO BE SET BY RESOLUTION, AND REPEALING ORDINANCES 1621 AND 1623.

WHEREAS, the City has conducted a comprehensive study of user fees, which the City Council is prepared to implement via a series of resolutions, and

WHEREAS, Ordinance 1621 establishes certain plan review and processing fees that would be in conflict with the new fee schedule to be adopted by resolution, and

WHEREAS, Ordinance 1623, codified as Chapter 13.21 of the Redmond Municipal Code, establishes storm water plan review and processing fees that would be in conflict with the fee schedule to be adopted by resolution, and

WHEREAS, in order to resolve the conflict, the City Council has determined to amend Chapter 13.21 of the Redmond Municipal Code and repeal Ordinances 1621 and 1623,

NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO
ORDAIN AS FOLLOWS:

Section 1. Chapter 13.21 Amended. Chapter 13.21 of the Redmond Municipal Code is hereby re-titled and amended to read as follows:

Chapter 13.21

**STORM WATER ENGINEERING,
PLAN REVIEW AND PROCESSING FEES**

Sections:

13.21.010 Purpose.

13.21.020 Plan Review and Processing Fees

13.21.010 Purpose. The purpose of this Chapter is to authorize the imposition of fees and charges for performance of various administrative storm water engineering, plan review and processing within the City.


13.21.020 Plan Review and Processing Fees. The fees for performance of various administrative storm water engineering, plan review and processing shall be set by Council Resolution.

Section 2. Repealer. Ordinances 1621 and 1623 of the City of Redmond, passed by the City Council on April 2, 1991, are hereby repealed.

Section 3. Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 4. Effective Date. This ordinance, being an administrative action, is not subject to referendum and shall take effect five (5) days after publication of an approved summary thereof consisting of the title.
