

ORDINANCE NO. 1990

ORIGINAL

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING SECTION 7.04.210(D) OF THE REDMOND MUNICIPAL CODE RELATING TO THE ADOPTION OF IMPOUNDED DOGS AND CATS IN ORDER TO MAKE THE SAME CONSISTENT WITH SECTION 11.04.210 OF THE KING COUNTY CODE.

WHEREAS, the City of Redmond has entered into a contract with King County to collect license and other fees and costs and to enforce the provisions of Chapter 7.04 of the Redmond Municipal Code relating to animal control, and

WHEREAS, the contract requires that the City adopt and maintain animal control regulations which are consistent with those adopted and maintained by the County, and

WHEREAS, King County has amended Section 11.04.210 of the King County Code in order to revise the regulations relating to the adoption of impounded dogs and cats, and

WHEREAS, the City Council has therefore decided to amend Subsection 7.04.210(d) of the Redmond Municipal Code in order to be consistent with the amended County regulation, NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON DO ORDAIN AS FOLLOWS:


Section 1. Adoption of Impounded Dogs and Cats. Subsection 7.04.210(d) of the Redmond Municipal Code is hereby amended to read as follows:

(d) Any animal not redeemed shall be treated in one of the following ways:


1. Made available for adoption at a fee set by City Council resolution.

Section 2. Severability. If any section, sentence, clause or phrase of this Ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this Ordinance.


Section 3. Publication/Effective Date. This Ordinance, being an exercise of a power specifically delegated to the City legislative body, is not subject to referendum and shall take effect five (5) days after passage and publication of an approved summary thereof consisting of the title.
