

CITY OF REDMOND, WASHINGTON

RESOLUTION NO. 201

A RESOLUTION, relating to streets and highways; and adopting a functional classification of arterials and other streets within the City of Redmond in accordance with uniform standards established by the Urban Arterial Board of the State of Washington.

WHEREAS, Section 24, Chapter 83, Laws of 1967 (Ex. Sess.), provides that the legislative authority of each city lying within or having within its boundaries an urban area shall, with the advice of its chief engineer, divide all of its streets into arterial streets and access streets and shall further subdivide the arterials into three functional classes to be known as major arterials, secondary arterials, and collector arterials, all in accordance with uniform standards established by the Urban Arterial Board of the State of Washington; and

WHEREAS, the Public Works Director, as chief engineer for the City, has divided, subdivided and classified all of the streets within the City of Redmond in accordance with such uniform standards and has forwarded such classification to the Urban Arterial Board and recommends its adoption by the City Council; and

WHEREAS, the City Council has examined the recommendations of the Public Works Director, and finds the same to be in the best interests of the City of Redmond and in accordance with sound principles of urban street planning, NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF REDMOND DO RESOLVE as follows:

Section 1. That the recommendations of the Public Works Director are hereby approved and adopted, and the streets within the City of Redmond are hereby divided and classified into arterial streets and access streets and the arterials are further subdivided and classified into three functional classes to be known as major arterials, secondary arterials, and collector streets in accordance with the uniform standards established by the Urban Arterial Board, all as shown and delineated upon the attached map, dated June 4, 1968,


entitled "City of Redmond - Urban Arterial Functionally Classified System," which is incorporated by reference as a part of this Resolution.

Section 2. That any previous action taken by the Public Works Director in connection with the division and classification of the streets of the City of Redmond in conjunction with the Urban Arterial Board and as approved and adopted by this Resolution prior to the effective date hereof is hereby ratified and confirmed.

Section 3. This Resolution shall take effect and be in force immediately upon its adoption and approval.
