On June 2, 2015, the Office of the Hearing Examiner received a request to clarify Item 19 of the May 26th Order Setting Hearing and Pre-Hearing Schedule.

Order

The following clarifications and changes are hereby made to the May 26, 2015 Order:

1. Item 19 of the Order is clarified and changed as follows:

For the purpose of satisfying the deadlines in Items 12 through 15 of the May 26th Order, the witness list, exhibit list, the exhibits themselves, and attorney-prepared legal briefing (if any) shall be submitted via email to the Office of the Hearing Examiner (email address below). In addition to email submission, on or before the day of the hearing each party shall provide a complete paper set of exhibits to each other party and two sets to the Examiner (one for the official record, one for working copies) with the following exception:

Appellants do not need to provide a complete paper set of their exhibits to the other Appellants; however each Appellant must provide a complete paper set to the Applicant, the City, and two copies for the Examiner.

Each party's complete paper set of exhibits shall have as a cover sheet that party's exhibit list, prepared consistent with Item 18 of the May 26th Order as a Word document with no table or columns.

2. Item 22 of the May 26th Order is changed as follows:

To be considered timely, submittals shall be sent via email not later than 4:00 pm on the due date. All submittals shall be directed to the attention of the Office of the Hearing Examiner, Attention Cheryl Xanthos. The Office of the Hearing Examiner will circulate all submittals to all parties.
