This is a similar situation for Metro as they also have stops along Avondale. The district will utilize Metro pull-outs whenever possible and also use a limited number of bus stops along Avondale. In addition, the district maximizes the number of riders per stop in order to minimize the number of stops. This has proven to be more efficient than having more stops and fewer riders per stop.
