ORDINANCE NO. 2033

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, APPROVING THE LAKESIDE MASTER PLANNED RESIDENTIAL DEVELOPMENT (MPRD), CITY FILE NO. MPRD96-001, SUBJECT TO CONDITIONS, AND ADOPTING THE HEARING EXAMINER'S FINDINGS AND CONCLUSIONS.

WHEREAS, Lakeside Industries filed an application for a master planned residential development (MPRD) on November 4, 1996, and subsequently filed an application for preliminary plat approval on April 16, 1997, and

WHEREAS, in order to fulfill SEPA requirements and to assess the environmental impacts of the MPRD and preliminary plat, an addendum to the Southeast Redmond Sub-area EIS was completed and published on August 10, 1999, and

WHEREAS, the Hearing Examiner held a public hearing on the MPRD and preliminary plat applications on August 25, 1999 and, after completion of the hearing, adopted findings and conclusions, a decision approving the preliminary plat, and a recommendation that the MPRD be approved, and

WHEREAS, the City Council reviewed the Hearing Examiner's recommendation on the MPRD on October 5, 1999 and determined to approve the same, and

WHEREAS, the MPRD must be approved by ordinance, NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO

ORDAIN AS FOLLOWS:

Section 1. MPRD Approved. The Lakeside Master Planned Residential Development, MPRD96-001, is hereby approved, subject to the conditions recommended by the Hearing Examiner in his Findings, Conclusions and Recommendation issued on September 8, 999.

Section 2. Findings and Conclusions Adopted. In support of the approval granted in Section 1, the City Council hereby adopts the Hearing Examiner's Findings, Conclusions, and Recommendation issued on September 8, 1999.

Section 3. <u>Duties of Planning Director</u>. The Planning Director is hereby authorized and directed to make any appropriate notations on the official zoning map of the City in order to reflect the approval of the MPRD as provided in this ordinance.

Section 4. Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 5. Effective Date. This ordinance, being an exercise of a power specifically delegated to the City's legislative body, is not subject to referendum, and shall take effect five (5) days after passage and publication of an approved summary thereof consisting of the title.
