RESOLUTION NO. 243

A RESOLUTION, approving an Amendatory Grant Agreement, making certain modifications in the Grant Agreement between the City of Redmond and the United States of America, Secretary of Housing and Urban Development (HUD), dated March 12, 1970, and authorizing the Mayor and City Clerk to execute the same.

THE CITY COUNCIL OF THE CITY OF REDMOND DO RESOLVE AS FOLLOWS:

WHEREAS, the City of Redmond, Washington, has heretofore approved and executed a Grant Agreement dated March 12, 1970, with the United States of America, Secretary of Housing and Urban Development, for the grant under Title VII of the Housing and Urban Development Act of 1965, in connection with the Project referred to in said Agreement; and

WHEREAS, the United States of America, Secretary of Housing and Urban Development, has tendered an Amendatory Grant Agreement incorporating certain modifications in the grant agreement; and

WHEREAS, said Amendatory Grant Agreement has been duly read in open meeting, fully considered in accordance with all pertinent rules of procedure and legal requirements, and made a part of the records of the City of Redmond, Washington; and

WHEREAS, it is deemed advisable and in the public interest that said Amendatory Grant Agreement be approved and its execution authorized, NOW, THEREFORE,


THE CITY COUNCIL OF THE CITY OF REDMOND DO RESOLVE AS FOLLOWS:

AMENDATORY GRANT AGREEMENT

THIS AMENDATORY GRANT AGREEMENT, dated as of March 31, 1970, by and between the City of Redmond, Washington (herein called the "Applicant") and the United States of America, Secretary of Housing and Urban Development (herein called the "Government"), WITNESSETH:

WHEREAS, the Grant Agreement between the Government and the Applicant dated March 12, 1970, provides a grant to the Applicant of \$153,800; and

WHEREAS, the Grant Agreement should reflect that the Government will make a Grant in an amount not to exceed \$153,800 or 50 percent of the Eligible Project Cost as determined by the Government on completion of the Project, whichever is the lesser, in order to aid in financing the Project hereinafter defined, presently estimated to cost \$611,300;

NOW, THEREFORE, for and in consideration of the mutual benefits flowing to the Government and to the Applicant, said Grant Agreement is hereby amended as follows:

In Section 1, Amount and Purpose, in line 3, insert the figure "50" in front of the word "percent".

THIS AMENDATORY GRANT AGREEMENT shall become effective as of the date hereof and all of the provisions of the original Grant Agreement, except as hereby amended, shall remain in full force and effect.
