- "(2) Enter into an agreement with the county pursuant to which the City shall participate in preparing a joint city-county plan for solid waste management"
- 2. Confirmation of intent to enter into agreement. The City does hereby re-confirm its intent and desire to enter into an agreement with King County, Washington, for participation in

a comprehensive solid waste management plan on a joint citycounty basis in keeping with previous correspondence between the City and King County.
