## CITY OF REDMOND ORDINANCE NO. 2820

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, AMENDING ORDINANCE NO. 2773, AS AMENDED BY ORDINANCE NO. 2793, BY MAKING ADJUSTMENTS TO THE CITY'S 2015-2016 BIENNIAL BUDGET, IN EXHIBIT 1

WHEREAS, the Finance Director has identified the need to make certain revisions to the 2015-2016 biennial City budget; and

WHEREAS, the City Council has reviewed the proposed adjustments to the budget and has determined that they should be made.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Ordinance No. 2773 adopting the 2015-2016 biennial budget, passed by the City Council on December 2, 2014, and as amended by Ordinance No. 2793, is hereby amended to recognize the proceeds and related expenditures from the refinancing of the City debt, receipt of grant funds, modification of King County ALS and BLS agreements and the transfers between funds.

Section 2. Severability. If any section, sentence, clause, or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such

invalidity or unconstitutionality shall not affect the validity of any other section, sentence, clause, or phrase of this ordinance.

Section 3. Effective date. This ordinance shall become effective five days after its publication, or publication of a summary thereof, in the city's official newspaper, or as otherwise provided by law.
