# ORDINANCE #30.

An Ordinance Regulating Motor Vehicles On The Streets Of The Town Of Redmond, And Repealing Section Two Of ORDINANCE #11, And Fig. Penalties For The Infringement Thereof.

BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF REDMOND AS FOLLOWS:

The words and phrases herein used unless the same be clearly contrary to or inconsistent with the context of the acts or sections in which used, shall be construed as follows: Motor vehicles shall include all vehicles or machines propelled by any power other than muscular used upon the high-ways or streets of the Town of Redmond.

# SECTION L

Every motor vehicle shall be provided with good and sufficient brakes, and with suitable bell, horn, or other signal, which shall be rung, blown or sounded as a signal or warning to any person or whenever there is danger of collision or accident, and at no other time.

#### SECTION II.

No person driving or operating a motor vehicle shall drive or operate the same in any other than a careful and prudent manner, nor shall use any greater speed than is reasonable or proper, having due regard to the traffic, and the use of the way by others, nor so as to enganger the life or limb of any person.

# SECTION III.

In no case shall any motor vehicle be driven, operated, or moved at a rate of speed faster than one mile in five minutes at any crossing within the main thickly settled or business portion of the Town of Redmond, or within one hundred yards of any school house on school days between the hours of eight o'clock in the morning and five o'clock in the evening, nor within any portion of this Town of Redmond, faster than one mile in three minutes.

### SECTION IV.

Every motor vehicle using an internal combustion engine shall use an exhaust muffler, and the same shall not be cut out or disconnected within the limits of the Town of Redmond.

#### SECTION V.

Every motor vehicle upon the streets of the Town of Redmond shall exhibit during the period from one-half after sunset to one-half hour before sunrise, and at all times when fog or other atmospheric conditions render the operation of said vehicles dangerous to traffic or the use of the streets, at least two head lights visible at least five hundred feet or more in advance of said vehicle. Such motor vehicles or any trailer attached thereto, shall have attached to the rear, not less than one light showing a red light visible at least two hundred feet in the rear of such vehicle and the same light or additional light casting white rays of sufficient strength on the rear number plate thereof so that such number plate may be easily read at a distance of at least 60 feet, provided that motor—cycles shall be required to carry only one light in the front thereof, which shall show white or yellow tinted rays visible at least five hundred feet in advance of such motor vehicle. Provided further that it shall be unlawful to display any light showing red to the front of any motor vehicle.

SECTION VI

The foregoing sections of this ORDINAN CE do hereby repeal Section Two of Ordinance #11 of the Town of Redmond.

#### SECTION VII.

Any one violating any of the provisions of the Ordinance shall be guilty of a mis-demeanor, and upon conviction thereof, shall be punished accordingly, either by fine or imprisonment or both. Imprisonment shall be not less then five days nor more than thirty days, the fine shall be not less than \$15 and not nore than \$100 or both.
