- l. Acceptance of financial aid offer. The City of Redmond does hereby accept the Offer of Financial Aid by the Economic Assistance Authority, State of Washington, for a loan in an amount not exceeding \$75,000.00 at interest at 5% per annum for aid in financing the cost of public facilities consisting of the installation of sewers along N.E. 116th Street and Willows Road to be constructed in accordance with the plans and specifications approved by the Department of Public Works of the City of Redmond. A copy of the Offer of Financial Aid is attached hereto, marked Exhibit "A" and by reference made a part hereof.
- 2. Authorization to sign agreement. The Mayor and City Clerk are hereby authorized and empowered to sign and execute an agreement between the State of Washington, Economic Assistance Authority and the City of Redmond, Washington, for aid in financing the cost of public facilities as above described in a loan amount not to exceed \$75,000.00, at interest of 5% per annum with a payment schedule to be mutually agreed by and between the parties to said agreement. A copy of such agreement is to be attached hereto, marked Exhibit "B" and by reference made a part hereof.
