RESOLUTION NO. 331

A RESOLUTION, approving an agreement between the Cities of Bellevue, Bothell, Kirkland, Redmond and Renton to provide for joint funding of a public defender program through application for a grant under the Omnibus Crime Control and Safe Street Acts of 1968; and authorizing the Mayor and City Clerk to execute the agreement on behalf of the City of Redmond.

WHEREAS, the Cities of Bellevue, Bothell, Kirkland, Redmond and Renton are by statute and court rule required to provide public defender services to indigent defendants charged with violations of city ordinances within their respective jurisdictions; and

WHEREAS, under the Omnibus Crime Control and Safe Street Acts of 1968, there are granted moneys to assist in funding such a program and the City of Bellevue is willing to act as the lead agency in making such an application and in administering the funds should a grant be awarded, Now, Therefore,


THE CITY COUNCIL OF THE CITY OF REDMOND DO RESOLVE AS FOLLOWS:

1. Agreement approved. That certain agreement between the Cities of Bellevue, Bothell, Kirkland, Redmond and Renton, dated January ____, 1974, and providing for a joint application for a grant under the Omnibus Crime Control and Safe Street Acts of 1968; providing for a contribution of matching funds if said grant is approved; and providing for the administration of the fund for purposes of funding a public defender's program for the cities involved, is hereby approved.

2. Mayor empowered to execute agreement. The Mayor and City Clerk are hereby empowered to execute such agreement on behalf of the City of Redmond.



AGREEMENT

THIS AGREEMENT, entered into this 1 day of January, 1974, by and between, THE CITY OF BELLEVUE, THE CITY OF BOTHELL, THE CITY OF KIRKLAND, THE CITY OF REDMOND, and THE CITY OF RENTON, all Municipal Corporations of the State of Washington,

W I T N E S S E T H :

WHEREAS, the parties hereto desire to provide public defender services to indigent defendants charged with violations of City ordinances within their respective jurisdictions, and

WHEREAS, the parties hereto desire to obtain funding to finance said services, and

WHEREAS, it is desirable that the parties hereto obtain a grant to provide said funding, now, therefore,

IT IS HEREBY MUTUALLY PROMISED AND AGREED:

1. The City of Bellevue shall file an application, on behalf of the parties hereto, with the Law and Justice Planning Office of the Planning and Community Affairs Agency of the State of Washington for a grant under the Omnibus Crime Control and Safe Streets Act of 1968. Any grant funds so obtained shall be used solely for the purposes specified in said application, which is attached hereto as Exhibit A and by reference, incorporated herein.

2. Said application has been prepared on behalf of the parties by the City of Bellevue, and is hereby approved by all parties to this agreement.

3. City of Bellevue shall have responsibility for the preparation and submission of any progress reports and reimbursement requests required under said grant.

4. Under the terms of said grant, if approved, each party will be required to contribute matching funds, as more fully set out in Exhibit A. Said matching funds shall be deposited with the City of Bellevue by each party within ten days after receiving notice from Bellevue that said grant has been awarded. All funds received under said grant shall be deposited with the City of Bellevue, which shall act as manager of the same. The funds received under said grant are intended to fund the services specified more particularly in Exhibit A attached hereto during the period January 1, 1974 through December 31, 1974. For each quarter of said period, each party hereto shall submit to the City of Bellevue, in the manner prescribed by the administrative office of the City of Bellevue in charge of management of said grant fund, a request for reimbursement for costs incurred. Reimbursement shall be made by the City of Bellevue after a review of all requests by said administrative official, said reimbursement also to be made on a quarterly basis.

5. Each party hereto will be responsible for executing, on its own behalf, a contract with the King County Office of Public Defense for the provision of legal and related services.
