CITY OF REDMOND, WASHINGTON RESOLUTION NO. 350 A RESOLUTION, relating to the public water supply and system; and requesting the King County Department of Records & Elections to call a special election of the voters of the City of Redmond, Washington, on the question of "Fluoridation of City Water System". WHEREAS, a number of residents of the City of Redmond have requested that the City Council fluoridate the City water supply and system that is not now receiving such treatment and that the City Council cause a proposition to be placed before the voters of the City as an advisory ballot to obtain citizen input and direction to the City Council; and WHEREAS, the City Council has considered the question of fluoridation of the City water supply system and deems it advisable to refer the matter to a vote of the registered voters of the City of Redmond at a special election held within the City for such purposes; and WHEREAS, the City Council finds that an emergency exists requiring such special election and that a special election should be held at the same time and in conjunction with the State general election on November 5, 1974; Now, Therefore, THE CITY COUNCIL OF THE CITY OF REDMOND DO RESOLVE AS FOLLOWS: Section 1. That the Department of Records and Elections of King County, Washington, be authorized and requested to call a special election within the City of Redmond at the same time and in conjunction with the general election on November 5, 1974, upon the proposition of whether the City Council of the City of Redmond, Washington, should provide for the fluoridation of the City water supply and system not now receiving fluoridation treatment. Section 2. That the following proposition be submitted to the registered voters of the City at such special election: PROPOSITION NO. I "FLUORIDATION OF CITY WATER SYSTEM" "Shall the City Council of the City of Redmond, Washington, provide for the fluoridation of the City water supply and system not now receiving such fluoridation treatment in the distribution of City water for domestic consumption?" Section 3. That the City Attorney is hereby authorized and empowered to make changes in the wording of the above proposition and ballot title should such changes be found necessary or appropriate, so long as the essential purpose thereof is met. Section 4. That an emergency is hereby found to exist, requiring that the above proposition be placed before the registered voters at a special election hereby called for such purposes; and the Department of Records and Elections of King County, Washington, is hereby requested to concur in such emergency hereby found to exist. Section 5. That the expenses of such special election shall be borne and paid by the City of Redmond as provided by law. Resolution No. 350 **-** l -

Section 6. That this Resolution shall be in force and take effect immediately.
