170th Place Northeast PROPOSED STREET VACATION

That portion of the Southwest quarter of Section 13, Township 25 North, Range 5 East, W.M., described as follows:

Beginning at the northeast corner of Lot 9, plat of Hollybrook, Volume 100, pages 86 and 87, records of King County, Washington;

Thence S 89°12'18" E a distance of 55.32 feet; thence S 11°44'12" E a distance of 59.35 feet to the beginning of a curve to the left; thence southeasterly along said curve to the left, having a radius of 53.00 feet, through a central angle of 122°04'18", to a point on the northerly margin of N.E. 42nd Street, said point lying 27.00 feet north of the centerline of N.E. 42nd Street; thence westerly to a point on the south line of Lot 9 of the plat of Hollybrook, said point lying 40.04 feet east of the southwest corner of Lot 9, and also lying 25.00 feet north of the centerline of N.E. 42nd Street; thence northeasterly along a curve to the left, through a central angle of 17°01'59", an arc distance of 37.16 feet to a point on a curve to the left; thence northerly along said curve to the left, having a radius of 25.00 feet, through a central angle of 86°47'42", an arc distance of 37.87 feet to a point on a reverse curve; thence northerly along said curve to the right, through a central angel of 8°45'09", an arc distance of 16.35 feet; thence N 11°44'12" W a distance of 71.35 feet to the point of beginning.
