RESOLUTION NO. 453

A RESOLUTION, establishing priorities for community development program and projects for block grant funds under the Housing and Community development Act of 1974, Pub. L. 93-383 for 1978-80; and approving project applications for the calendar year 1978.

WHEREAS, King County is an urban county applicant for block grant funds under the Housing and Community Development Act of 1974, Pub. L. 93-383, and an Urban County Consortium has been established by interlocal cooperation agreements between the County and certain local municipal corporations within the County to which the City of Redmond is a party; and

WHEREAS, in furtherance of said interlocal cooperation agreements and to qualify for reimbursement of eligible block grant community development programs under the Act, the City Council has duly held public hearings on August 16, 1977, and November 15, 1977, and following such public hearings has established priorities for community development block grant programs and projects within the City of Redmond and has approved the submission of appropriate applications therefor; Now, Therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND DO RESOLVE AS FOLLOWS:

1. Priorities for Block Grant Community Development Programs established. The following community development programs and projects within the City of Redmond have been identified and will be submitted to King County for allocation and approval for block grant funding in the order of priority established below until the City's Housing and Community Development Fund entitlement has been exhausted; provided, that in the event any higher priority programs and projects are determined to be ineligible for block grant funds, available funding shall be utilized for the programs and projects next prioritized:

Priority No.	Project Title
1	Housing Rehabilitation (Repair 5 - 10 sub-standard homes)
2	Senior Citizen Transportation Services (Continuation of the lease and operation of a passenger van for senior citizens)
3	Continuation of 1977 Walkway Construction (Request for more funds to cover the increased 1977 project cost)
4	Walkway Construction, Old Redmond Road (Design and construction of 1,175 lineal feet of concrete sidewalk)
5	Anderson Park Improvement (Street and sidewalk improvement abutting two sides of Anderson Park)

6	Walkway Construction, Redmond-Woodinville Road (Design and construction of 2,400 lineal feet of concrete sidewalk)
7	Walkway Construction, N.E. 51st Street (Design and construction of 3,155 lineal feet of concrete sidewalk)
8	Nike Site Community Center Master Plan (Planning of the Nike Site as a community center)

2. Applications approved. The submission of appropriate applications and agreements for block grant funding of the community development programs and projects for the City of Redmond, set forth above under Paragraph 1 of this Resolution, is hereby approved.
