

RESOLUTION NO. 607

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, COMMENDING PAUL F. KUSAKABE FOR EXEMPLARY SERVICES RENDERED TO THE CITY AND PROCLAIMING HIS SELECTION AS 1981 "EMPLOYEE OF THE YEAR" BY THE CITY COUNCIL.
