RESOLUTION NO. 715

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, ESTABLISHING A DATE AND TIME FOR A PUBLIC HEARING TO CONSIDER THE FORMATION OF A LOCAL IMPROVEMENT DISTRICT TO BE DESIGNATED LID NO. 85-ST-49, PURSUANT TO THE PETITION METHOD FOR THE PURPOSE OF MAKING TRAFFIC SIGNAL AND RELATED STREET IMPROVEMENTS AT 151st PLACE AND N.E. 24th STREET.

WHEREAS, a petition has been filed with the City requesting the formation of a local improvement district for the purpose of accomplishing certain traffic signal and related street improvements, at the intersection of 151st Place and N.E. 24th Street, and

WHEREAS, the date, time and place of a public hearing to consider the proposed local improvement district and improvements should be established, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

Section 1. A public hearing shall be conducted before the Redmond City Council on September 3, 1985, at 8:00 PM, or as soon thereafter as the matter may be heard, in the City Council Chambers at Redmond City Hall, Redmond, Washington, to consider the formation of a local improvement district for the purpose of carrying out traffic signal and related street improvements at the intersection of 151st Place and N.E. 24th Street. All persons who may desire to speak for or against the proposed local improvement district and improvements herein mentioned are invited to comment in person at the public hearing or to submit written comments to the Department of Public Works at Redmond City Hall.

Section 2. The City Engineer of the City of Redmond is hereby directed to submit to the City Council at or prior to the day of the hearing, the estimated cost and expense of the proposed improvements and a statement of the aggregate valuation

of the real estate and 25% of the actual valuation of the improvements thereon within the said proposed improvement district, according to the last valuation placed on it for general taxation, together with a diagram or print showing thereon the lots, tracts or parcels of land or other property which will be specially benefited thereby, and the estimated amount of the cost and expense of such improvements to be borne by each such lot, tract, parcel or parcels of land or other property.
