RESOLUTION NO. 736

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON STATING THE INTENTION OF THE CITY COUNCIL TO AMEND ORDINANCE NO. 1132, AS PREVIOUSLY AMENDED, TO REVISE THE BOUNDARIES OF LOCAL IMPROVEMENT DISTRICT NO. 82-ST-44 TO INCLUDE ALL PROPERTY SPECIALLY BENEFITED BY THE LID IMPROVEMENTS, AND ESTABLISHING A DATE AND TIME FOR A PUBLIC HEARING TO CONSIDER THE REVISION OF THE BOUNDARIES OF SAID LID NO. 82-ST-44 AND THE FINAL ASSESSMENT ROLL FOR THE EXPANDED LID.

WHEREAS, On June 21, 1983, the City Council adopted Redmond City Ordinance No. 1132 which ordered the construction and installation of certain improvements described therein, and created Local Improvement District 82-ST-44, and

WHEREAS, Ordinance No. 1132 was amended by Ordinance No. 1297, passed by the City Council on February 4, 1986, to correct the description of LID improvements, and

WHEREAS, after construction of the improvements ordered by said Ordinance No. 1132, as amended, and after publication and mailing of notices as required by law, a public hearing was conducted to receive testimony concerning the final assessment roll for LID 82-ST-44, which hearing has been continued until March 25, 1986 at 7:30 p.m. in the City Council Chambers, and

WHEREAS, as a result of testimony received at such public hearing, it appears to the City Council that property which is specially benefited by the improvements has been omitted from the

LID at the time of its formation and that in order to insure that the cost of the improvements is equitably assessed against all properties which are specially benefited by the improvements, the boundaries of LID 82-ST-44 should be revised to include additional property which is specially benefited, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

Section 1: It is the intention of the City Council to amend Ordinance No. 1132, passed by the City Council on June 21, 1983, as previously amended by Ordinance No. 1297, passed by the City Council on February 4, 1986, by revising the boundaries of LID 82-ST-44 to include all property specially benefited by the improvements. The proposed boundaries of the LID, as so revised, are set forth and described in Exhibit A, attached hereto and incorporated herein by this reference as if set forth in full.

Section 2: Tuesday, March 25, 1986 at 7:30 p.m., in the City Council Chambers, Redmond City Hall, Redmond, Washington, is hereby set as the time, date and place of a public hearing for the purpose of considering all matters relating to the revision of the boundaries of LID 82-ST-44 and all objections thereto. All persons who may desire to object to the revision of the boundaries of LID 82-ST-44 and the amendment of Ordinance No. 1132, as previously amended, are hereby notified to appear and present their objections at the time fixed for the hearing.

Section 3. The City Engineer is hereby directed to revise the final assessment roll for LID 82-ST-44 to include within said roll the property identified on Exhibit A, and to modify all

assessments as appropriate to include the portion of the costs of the LID improvements which should be assessed against said property and to adjust the assessments against other properties as appropriate in order to assure that the assessments are proportional one to another.

Section 4: The date, time and place stated in Section 2 above is also established for the hearing of all objections to the final assessment roll relating to the property which will be added to the LID if the boundaries are expanded as set forth above. All persons who may desire to object to the assessments set forth on said roll for the property to be added as identified on Exhibit A hereto are directed to file their written objections with the City Clerk at Redmond City Hall at or prior to the date and time of the hearing and to appear at the hearing to present evidence and argument in support of such objections. Any objections not filed and presented as directed in this Section shall be deemed to have been waived and shall not be considered by the City Council.

Section 5: The City Clerk is hereby directed to give notice of the hearing on this resolution of intention to amend Ordinance No. 1132 and to revise the boundaries of LID 82-ST-44 and to give notice of the hearing on the final assessment roll as it pertains to property within the revised boundaries of the LID by publication and by mailing, in the manner required by law, and to give notice of the special Council meeting fixed for March 25, 1986 at 7:30 p.m., pursuant to the Open Public Meetings Act.
