I. RECOMMENDED ACTION

III. DESCRIPTION/BACKGROUND

A. Applicant: Don McManamen, for Aerojet

B. Location: Southside of Aerojet Campus; 13750 NE 110th Court

- C. <u>Use Detail</u>: The applicant has requested approval to site two (2) 8'x40' metal ocean going storage containers (Attachment C.). The containers are to be used for storage of tooling and product hardware including bolts, screws, o-rings, gaskets, etc., until a permanent structure is added to the Aerojet Campus. To date, no application has been made for a new permanent structure. The proposed location is well screened from surrounding properties by existing mature evergreen trees (Attachment D.).
- **D.** <u>Duration</u>: This long term temporary use permit will be for 18 months from the effective date of the Ordinance (Attachment A.), if adopted.
- E. <u>Conditions</u>: The Technical Committee recommends approval with conditions listed in **Attachment B**.

F. Notice: On October 21, City staff mailed the notice of application to neighbors within 500' of the subject property and notice was posted on site, City Hall, and Redmond Library. Notice of the public hearing was mailed to neighbors within 500', and posted notice on the site, City Hall, Redmond Library and in a one-time Seattle Times newspaper advertisement. To date, no comments have been received from the public regarding this project.

IV. IMPACT

<u>Service Delivery</u>: Staff does not anticipate any impact to service delivery, or fiscal impact, as a result of the approval of this project.

V. ALTERNATIVES

- A. Adopt the Ordinance with Technical Committee Recommended Conditions of Approval. The Technical Committee has recommended approval of the Aerojet Long Term Temporary Use Permit (L030271) with conditions. This alternative will allow Aerojet to move forward with its proposal with conditions outlined by the Technical Committee.
- **B.** Approve the Ordinance with modifications. The City Council may choose to approve the ordinance with modifications, based on Council findings that alternate conditions would better implement adopted regulations. This action would likely result in a redesign of the project.
- C. Not approve the Ordinance. The City Council may choose not to approve Aerojet Long Term Temporary Use Permit (L030271), based on findings that the project, as designed, is inconsistent with adopted regulations. This action would result in the developer having to redesign the project.

VI. TIME CONSTRAINTS

The applicant has indicated to staff that their business is growing rapidly both in number of employees and contract backlogs, and wishes to install the storage containers as soon as possible.

A. Design Requirements to be Completed Prior to Permit:

1. Erosion control systems must be implemented throughout the construction process and until the site is stabilized. Design of all systems must be in accordance with section 20E.90.10 of the Community Development Guide and the most recent issue of the City of Redmond STORMWATER MANAGEMENT AND EROSION CONTROL TECHNICAL NOTEBOOK (notebook). Contact the Stormwater Division at 556-2890 for information about, or a copy of, the notebook. Preferred methods for management and control are discussed in the notebook.

2. Stormwater Management

This project meets the definition of a re-development project. Due to the proposed additional impervious area being under 5,000 square feet, no new detention or permanent water quality facilities are required.

3. Site grading shall not exceed a slope of 3 horizontal to one vertical measure, (3 to 1).

B. Miscellaneous:

- 1. Construction activities may be limited or suspended during the rainy season (October 1 April 30).
- 2. Two complete copies of plans, computations, and studies are required for a complete submittal. Only complete submittals will be accepted for review.
- 3. Stencil all on-site storm drainage inlets with "DUMP NO WASTE DRAINS TO STREAM". Stencils are available from the Stormwater Division located at the City Annex (phone 556-2840). Design plans shall identify the requirement to stencil drainage inlets.

4. A copy of the conditions of approval (this letter) must accompany all Grading and Storm drainage plan submittals.

The following conditions are integral to the Approval and shall be complied with in Civil Drawings, Recordings, Building Permit Submittals, Fire Code Permit submittal, and/or other applicable processes: Coordinate the following with the SPE approval.

- Fire Protection Plan: a Fire Protection Plan for the entire facility (site) shall be accomplished. Work with the Fire Department plan reviewer assigned for the building permits associated with this project to satisfactorily achieve this condition.
- Permits: a fire permit for all hazardous materials and other uses that require Fire Code Permits [as applicable at this facility (site)] shall be obtained from the Fire Department. Work with the Fire Department plan reviewer assigned for the building permits associated with this project to satisfactorily achieve this condition.
- Conditions: Comply with all applicable portions of the Fire Code. Work with the Fire Department plan reviewer assigned for the building permits associated with this project to satisfactorily achieve this condition.




