

ORDINANCE NO. 2280

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, ACCEPTING A DONATION OF FUNDS AND SOFTWARE FROM MICROSOFT UNLIMITED POTENTIAL GRANT PROGRAM, AND AUTHORIZING THE MAYOR TO EXECUTE ANY NECESSARY AGREEMENT WITH MICROSOFT REGARDING SUCH DONATION.

WHEREAS, Microsoft Unlimited Potential Grants Program is dedicated to improving the learning opportunities for individuals outside of formal traditional education settings by focusing on providing technology-related skills through community based programs, and

WHEREAS, Microsoft Unlimited Potential has identified the City of Redmond's Old Fire Teen Center as a community based program that provides learning opportunities for individuals outside of formal traditional education settings, and

WHEREAS, Microsoft Unlimited Potential has graciously offered to donate fifty thousand dollars (\$50,000.00) and software valued at nearly ten thousand dollars (\$10,000.00) for the purpose of assisting the Old Fire Teen Center's efforts to increase access to technology and technology-related skills of underserved persons, and

WHEREAS, RCW 35.21.100 authorizes the City to accept donations by ordinance and to carry out the terms of the donation as long as such terms fall within the scope of the City's delegated powers, and

WHEREAS, the City Council desires to accept the donation according to its terms, to authorize the Mayor to execute the Agreement for Donation with Microsoft

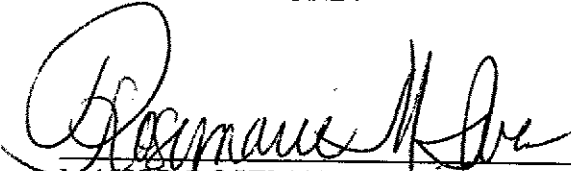
Unlimited Potential, and to express its appreciation to Microsoft Unlimited Potential, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON,
DO ORDAIN AS FOLLOWS:

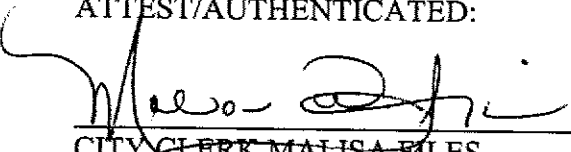
Section 1. **Acceptance.** The City Council hereby accepts the donation of fifty thousand dollars (\$50,000.00) and software valued at nearly ten thousand dollars (\$10,000.00) from Microsoft Unlimited Potential Grants Program for the purpose of assisting the Old Fire Teen Center's efforts to increase access to technology and technology-related skills of underserved persons. The City agrees to carry out the terms of the donation as set forth in the attached Exhibit A. The Mayor is hereby authorized to execute any necessary agreements with Microsoft to accept the donation on behalf of the City. The City Council expresses its appreciation to Microsoft Unlimited Potential for its generous donation.

Section 2. **Effective Date.** This ordinance, being an exercise of power specifically delegated to the City's legislative body, is not subject to referendum and shall take effect five (5) days after passage and publication of an approved summary thereof consisting of the title.

Established in 1992, the Old Fire House is a stand-alone teen center located in downtown Redmond, WA. Our mission is to provide innovative and progressive recreational, educational and social services to all Redmond area youth ages 13-19. Our objective is to provide a safe, positive place where teens can form relationships with both peers and adults, and have fun doing constructive activities that promote life long skills, confidence and a sense of community. The OFH is far from a typical recreation program, and is successful at engaging culturally diverse teens in a large variety of programs. 2005 attendance numbers reflect an average

of 350 teen visits each week.

What are the programs, activities, or services that your organization provides? (required)

Programming is constantly evolving to reflect current teen trends, and includes activities such as art workshops, photography classes, teen visual art shows, writing groups, current events discussion groups, adventure fieldtrips, weekly community dinners, studio recording classes, cooking classes, videography classes, skateboarding classes, and live music concerts. For a calendar of current offerings, see www.theoldfirehouse.org. We also partner with local agencies such as Friends of Youth, Youth Eastside Services and Worksource to provide counseling and personal support services for youth. The Old Fire House's 8000 sq. ft. facility includes a counselor's office, basketball court, game room, art gallery, darkroom, teen closet with a free clothing bank, skateboarding elements, a class room, silk screening studio, concert hall, kitchen, a garden courtyard, and a media lab with audio and video recording and editing capabilities. With base funding from City of Redmond's Redmond Parks & Recreation Department, we offer open access to our community's youth, and most of our programming is free of charge. Scholarships are available for activities such as concerts, workshop series, and field trips, which require a modest fee.

Our services are primarily offered to Redmond residents 13-19 years old but our policy is to not turn anyone away. Our all age's music venue has drawn audiences from all over western Washington. The Fire House is an open community and respects everyone that comes through our doors. We have a more diverse population than our community reflects based on what programs we are offering that day.

Tech It Up

Purpose of the Proposed Project (required)

Our current target population is at-risk and underserved populations in our area to be able to provide services that meet their needs. Currently we do not have the technology to support the programs that are being requested by participants. We would like to offer job skills programs, technology programs such as video and/or audio recording, advertising, and business related programs that offer a range of skills training. We would like to include inter-generational and/or multi-age programs if the needs are there. When these programs are offered it will allow a youth to develop the skills or the support systems that allow them to be successful for their future. Disenfranchised youth feel that they have no connections to anyone or place and so creating a space and then offering opportunities is what this project will try to do since many of the youth already are coming to the Fire House Teen Center.

Goal #1 of Project (required)

Prepare teens for the job market with IT and interpersonal skills.

Goal #2 of Project (required)

Provide access to at-risk and underserved youth to IT training and hardware.

Goal #3 of Project (required)

To be able to further enhance the creative skills that youth have in the areas of information technology.

Why is this program important to your community? (required)

Computer access is just as important to most teens as air, water or sleep. Computers are an integral part of teen life, and are used for creation, communication, work, research, socializing, and playing. A Microsoft technology bank would allow equal access to technology to all youth, regardless of cultural background or economic status. Old Fire House is successful at creating a safe, comfortable community space, where it is not uncommon for youth with limited resources to interact and participate in activities alongside youth with vast resources. A computer lab in such an environment is a tangible step in bridging the technological divide. Some of our participants are not successful or have dropped

out of school and this maybe the only place that they will have access to learning these skills. Low income, at-risk, and limited access youth in our community are attracted to the Fire House Teen Center and this population needs opportunities in a setting that they feel safe and are willing to come into. By providing access and opportunity we hope that they will not continue in their challenges and be able to use these skills to make better choices in their lives.

When comparing the numbers if we are able to offer training for youth and they see the long term benefits they will have more stable sources of income and skills that can be used in different areas. In the most recent information from the Bureau of Labor Statistics(BLS): Full-time workers age 25 and over without a high school diploma had median weekly earnings of \$404, compared with \$579 for high school graduates (no college) and \$1,013 for college graduates holding at least a bachelor's degree. Among college graduates with advanced degrees (professional or master's degree and above), the highest-earning 10 percent of workers made \$2,896 or more per week (BLS 2005).

How will IT skills training help the target group overcome their disadvantage? (required)

At-risk youth may not have access to technology as readily as other teens and this sets an immediate disadvantage. By offering these this in a friendly and supportive environment they are more likely to stay in school, be more focused, have skills like their peers, gain job skills that will increase their likelihood of

making a livable wage and overcome stereotypes of being disadvantaged.

Support and Follow Up (required)

Support systems are in place for all participants who come to the center. Due to the nature of program we are a drop-in program that allows participants to come and go. We always request a commitment from youth who participate in any of our programs for the duration of the class. With some of our community partners like Work Source we are able to refer to them for follow up and they have been good about maintaining communication so that we can continue the support of our teens. As the program develops we hope that relationships will be developed with the staff and volunteers so that teens feel comfortable in maintaining the connections that they have created. This is reflected in the many teens that have come to the center in the past 13 years with many of those who have returned to let staff know what they are up to or thank staff for their caring and support while they are hear. Unfortunately we do not hear all the success but ones that we do hear inspire us in the work that we do.

Assessing the Project (Measuring Progress)

Measure of Success (required)	How we would like to evaluate the program would be to initially have a pre and post evaluation for everyone who participates in the program. We would look at aspects like current skill levels, school achievement and involvement, past knowledge of computers, future outlook, and current job status. These are issues that we would like to address and have impact on. We may find other areas that would be helpful as we move through this process. Depending on the program offerings we see that these evaluations will be offered at least quarterly with a compiled report to Microsoft at the end of each year. We will try to contact past participants and see what their status is since the program for some longer term data but since this is a drop in program with a limited term program we may not have enough data to make the evaluations statistically valid versus just narrative data that would be included. We feel that if 70% of the participants show some type of change in their pre and post evaluations we would have shown success. The majority of the evaluations will be done with a Likert rating scale and movement on the scale in a positive direction would show change. The city has internal systems in place and we have staff that can coordinate, collate and analyze the data for reporting purposes as part of their staff time on this project. 2000 character maximum

Goal #1 Measurement (required)	Participants will be given a pre and post evaluation assessing the skills they have entering the program and what they feel they have learned at the end of the program. Social skills are important in a job and we will look at involvement in risk behaviors, school success (GPA) or involvement, attendance, and future outlook. Some instructor data will be gathered from observations and interactions about their learning, pre and post, their interaction and involvement in the program, their interpersonal skills. Based on the pre and post evaluations 70% of participants who complete the program will show an increase in the Likert measurement scale.

Goal #2 Measurement (required)

Success will be determined from the number of referrals of at-risk youth and their ability to complete the program. Information will be drawn from evaluation tools about their access to computers and ability to participate in the program. 70% of the participants will complete the program and 50% will have reported that they do not have access to computers on an as need basis.

Goal #3 Measurement (required)

Being able to offer such programs for youth in our eyes would be a success because currently there is none being offered for this target group in Redmond. The number of programs and participants will be used to determine success as the program develops if there is an increase in interest and need. We will ask as part of the evaluation process what they have been involved in and what they would like to see in the future.
