ORDINANCE NO. 2569

AN ORDINANCE OF THE CITY OF REDMOND,
WASHINGTON, ACCEPTING A DONATION OF SIX
BASEBALL SCOREBOARDS FROM REDMOND WEST
LITTLE LEAGUE AND AUTHORIZING THE MAYOR TO
EXECUTE AN AGREEMENT WITH REDMOND WEST
LITTLE LEAGUE REGARDING SUCH DONATION

WHEREAS, Redmond West Little League has graciously offered to donate six electronic baseball scoreboards and at Hartman Park, subject to certain terms and conditions; and

WHEREAS, RCW 35.21.100 authorizes the City to accept donations by ordinance and to carry out the terms of the donation if such terms are within the City's powers granted by law; and

WHEREAS, the City Council desires to accept the donation according to its terms and to express its appreciation to Redmond West Little League for its generosity.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

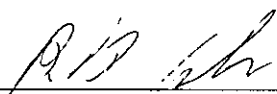
Section 1. Acceptance. The City Council hereby accepts the donation of four Nevco Model 1550 electronic baseball scoreboards with LED lights at Fields No. 1 through 4 at Hartman Park, from Redmond West Little League. The City Council also hereby accepts the donation of two Nevco Model 1510 electronic baseball scoreboards with LED lights at Fields No. 5 and 6 at

Hartman Park, from Redmond West Little League. The City agrees to carry out the terms of the donation, as set forth in the attached Agreement for Donation of Scoreboards, and the Mayor is hereby authorized to execute such Agreement on behalf of the City. The City Council expresses it's thanks to Redmond West Little League for its generous donation.

Section 2. Effective Date. This ordinance shall take effect five (5) days after publication of a summary consisting of the title.

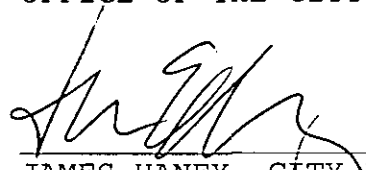
