## RESOLUTION NO. 1009

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, AUTHORIZING THE CITY'S DIRECTOR PLANNING OF AND COMMUNITY DEVELOPMENT TO EXECUTE CERTIFICATES OF LAND USE COMPLIANCE WHEN REQUIRED BY KING COUNTY ORDINANCE 11034 WITH RESPECT TO REQUESTS FOR CONNECTION INTO THE METRO **SEWERAGE** COLLECTION SYSTEM.

WHEREAS, by Resolution 2933, adopted April 6, 1978, the Municipality of Metropolitan Seattle (METRO), adopted rules and regulations for the disposal of sewerage into the METRO sewerage system, including procedures to ensure consistency between proposed connection and extensions of the METRO system and the adopted land use plans and policies of local governments, and

WHEREAS, since the merger of METRO and King County, METRO's rules and regulations have been incorporated into King County Ordinance 11034, and

WHEREAS, pursuant to such rules and regulations, a request for extension or connection will be considered by the County only upon receipt of a certification that such connection is consistent with the adopted land use plans and policies of local governments having jurisdiction over any portion of the area proposed to be served or any other area in and through which the facility is proposed to be constructed, and

WHEREAS, such certifications may be made by the legislative body of the local

government or any department of the local government that may be designated by the legislative

body, and

WHEREAS, the City's Director of Planning and Community Development, or her

designee, currently reviews all such projects and determines whether they are consistent with the

City's adopted land use plans and policies, and

WHEREAS, it would promote efficiency of consideration and approval of such

projects for the City's Director of Planning and Community Development to be authorized to

execute the certification required by King County Ordinance 11034 on behalf of the City with

respect to connections to the METRO system, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON,

HEREBY RESOLVES AS FOLLOWS:

Section 1. The City's Director of Planning and Community Development is

hereby authorized to review and execute on behalf of the City certificates of land use required

by King County Ordinance 11034 with regard to connections to the METRO/King County

sewerage system.
