

RESOLUTION NO. 1047

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON AUTHORIZING APPLICATION FOR FUNDING ASSISTANCE FOR THE SAMMAMISH VALLEY COMMUNITY PARK, TO THE INTERAGENCY COMMITTEE FOR OUTDOOR RECREATION UNDER CHAPTER 43.98A RCW, WASHINGTON WILDLIFE AND RECREATION PROGRAM.

WHEREAS, the City Council of the City of Redmond, Washington has approved the 1996 Redmond Comprehensive Plan and the 1997 Parks, Recreation and Open Space Plan (PRO Plan) that recommends acquiring and developing a community park in the Sammamish Valley, and

WHEREAS, under the provisions of the Washington Wildlife Recreation Program state funding assistance has been requested to aid in financing the cost of park land and facilities for local public agencies; and,

WHEREAS, the City Council of the City of Redmond considers it is in the best public interest to apply for grant funds from the Interagency Committee for Outdoor Recreation under Chapter 43.98A Revised Code of Washington; said funds to be used in the acquisition of park land and open space in the Sammamish Valley; now therefore

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON
HEREBY RESOLVES AS FOLLOWS:

Section 1. The Mayor is hereby authorized to make formal application to the 1997 Interagency Committee for Outdoor Recreation for funding assistance in the amount of \$300,000.

Section 2. Any funding assistance received as the result of this application shall be used in the acquisition of community park land and open space in the Sammamish Valley

Section 3. The City of Redmond anticipates that its local share of the project will be derived from 1989 King County Open Space funds and City of Redmond monies which would include, but would not be limited to, impact fees and capital improvement program funds;


Section 4. The City of Redmond acknowledges that any property acquired with Interagency Committee for Outdoor Recreation financial aid must be placed in use as an outdoor recreation facility and be retained in such use in perpetuity unless as otherwise provided and agreed to by the Redmond City Council, the Interagency Committee for Outdoor Recreation, and any affected federal agency.

Section 5. This resolution shall become part of a formal grant application to the Interagency Committee for Outdoor Recreation by the City of Redmond.

Section 6. The City of Redmond has provided appropriate opportunity for public comment on the acquisition of land in the Sammamish Valley. Public meetings were held in preparation for the 1996 King County Bond and the public workshops were held in preparation of the 1997 PRO Plan.
