A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, RELATING TO FEES FOR COMMUNITY USE OF REDMOND ELEMENTARY MULTI-USE FACILITY DURING THE INTERIM USE PERIOD

WHEREAS, Resolution No. 793, adopted April 4, 1989, and as subsequently amended, establishes a schedule of user fees including penalties, administrative charges, permit fees, license fees, etc., and

WHEREAS, the City Council, upon recommendation of the City's Parks and Recreation Department, has determined that the user fee schedule should be amended to include new rental fees for usage of the Redmond Elementary Multi-Use Facility during the interim operating period, November, 1997 through January 2, 1999, in order for the City to recoup a portion of its operating costs, now therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON,
HEREBY RESOLVES that new rental fees for usage of the Redmond Elementary Multi-Use
Facility, as set forth in Exhibit A attached hereto and incorporated herein by this reference as if
set forth in full, are hereby adopted. The schedule of user fees adopted by Resolution No. 793,
as amended for inflation pursuant to Resolution No 893, is further amended to include the fees
as described in Exhibit A.
