

RESOLUTION NO. 1064

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, AMENDING THE SCHEDULE OF PARK USER FEES ADOPTED BY RESOLUTION 793, AS AMENDED BY RESOLUTION 973, IN ORDER TO INCREASE AND SIMPLIFY FEES FOR THE RENTAL OF PICNIC AREAS AND FOR STAFF SUPPORT FOR SPECIAL EVENTS OR LARGE GROUPS.

WHEREAS, Redmond Parks and Recreation administers a group reservation system for picnic areas in four of the City's most popular parks during the spring and summer months, and

WHEREAS, the current system allows for the reservation of two half day (three hour) blocks of time per day with additional hours reserved on an hourly basis, and

WHEREAS, the current reservation fees are different for each of the parks involved, and

WHEREAS, in order to simplify the reservation system, the Parks and Recreation Department has recommended that the fees be the same for all parks and that the half day reservation blocks be increased to a maximum of five hours, and

WHEREAS, the fees have not been adjusted since 1993 and the Parks and Recreation Department has recommended an increase to compensate for inflation and to bring the fees into line with those charged by other cities, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON,
HEREBY RESOLVES AS FOLLOWS:

Section 1. Picnic Area Fees Amended. The fees for reservation of picnic areas in

City parks, as established by Resolution 793 and amended by Resolution 973, are hereby further amended to be as follows:


	<u>Resident</u>	<u>Non-Resident</u>
Half-Day (Max. 5 hours)	\$50	\$60
Full-Day	\$100	\$120

Section 2. Staff Support Fees Amended. The fees for staff support for special events or large groups, as established by Resolution 793 and amended by Resolution 973, are hereby further amended to be as follows:

Staff Support (Special Events or Large Groups if Necessary)	\$15/hour

Section 3. Effect of Amendments - Effective Date. Except as expressly amended herein, all other fees charged by the Parks and Recreation Department shall be unaffected by this Resolution. The fees provided herein shall take effect and apply to all reservations made after January 1, 1998.
