

RESOLUTION NO. 1076

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, IN SUPPORT OF THE RECENTLY COMPLETED *MOBILITY ACTION PRIORITIES* REPORT PREPARED UNDER THE DIRECTION OF THE EASTSIDE TRANSPORTATION PARTNERSHIP, IDENTIFYING THE HIGHEST PRIORITY SINGLE AND MULTI-JURISDICTIONAL TRANSPORTATION PROJECTS AND PROGRAMS FOR THE CITY OF REDMOND AND THE GREATER EASTSIDE.

WHEREAS, the *Mobility Action Priorities (MAP)* report was prepared under the direction of the Eastside Transportation Partnership; and

WHEREAS, the City of Redmond, through membership in the Eastside Transportation Partnership, participated in the development of the *Mobility Action Priorities* report; and

WHEREAS, the Eastside Transportation Partnership gathered public comment on transportation issues affecting Eastside residents and businesses through surveys and newspaper inserts; and

WHEREAS, public comment was used to help identify transportation priorities and compile the list of high priority transportation projects contained in the *Mobility Action Priorities* report; and

WHEREAS, transportation projects in the greater Redmond area contained in the *Mobility Action Priorities* report, are needed to provide mobility for Redmond citizens and businesses; and

WHEREAS, these transportation projects are needed to allow the City of Redmond to meet its transportation goals, level-of-service regulations, safety needs, and provide more transportation choices, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. The *Mobility Action Priorities* report prepared by the Eastside Transportation Partnership attached as Exhibit A hereto and incorporated herein by this reference as if set forth in full, is hereby adopted.


Section 2. The City of Redmond shall encourage development of a long-range regional transportation system as described in the *Mobility Action Priorities* report to provide for the mobility of citizens of Redmond and the greater Eastside.

Section 3. The City of Redmond shall use the *Mobility Action Priorities* report to seek and obtain funding for the transportation projects within and around Redmond, as part of a greater regional transportation system.

Section 4. The City of Redmond shall support, through the Eastside Transportation Partnership, ongoing efforts to use the *Mobility Action Priorities* report to identify and build transportation projects which will serve existing and future Redmond residents and businesses.
