

RESOLUTION NO. 1077

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON AUTHORIZING APPLICATION FOR FUNDING ASSISTANCE FOR AVONDALE COMMUNITY PARK TO THE INTERAGENCY COMMITTEE FOR OUTDOOR RECREATION UNDER CHAPTER 43.98A RCW, WASHINGTON WILDLIFE AND RECREATION PROGRAM.

WHEREAS, the City Council of the City of Redmond, Washington has approved the 1997 Parks, Recreation and Open Space Plan (PRO Plan) that includes Avondale Community Park, and

WHEREAS, the recreation facilities provided by a community park are identified in the PRO Plan as the City's greatest outdoor recreation need, and

WHEREAS, under the provisions of the Washington Wildlife and Recreation Program, state and federal funding assistance has been requested to aid in financing the cost of land and facilities, and

WHEREAS, the City of Redmond considers it in the best public interest to acquire and develop a community park in the northeast area of Redmond; now therefore

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON
HEREBY RESOLVES AS FOLLOWS:

Section 1. The Mayor is hereby authorized to make formal application to the 1998 Interagency Committee for Outdoor Recreation for funding assistance.

Section 2. Any funding assistance received as the result of this application shall be used in the acquisition and development of Avondale Community Park.

Section 3. That the City of Redmond's monetary share of the project will be derived from 1989 City of Redmond Bond funds and capital improvement project funds.

Section 4. That the City of Redmond acknowledges that any property acquired or facility developed with Interagency Committee for Outdoor Recreation financial aid must be placed in use as an outdoor recreation facility or habitat conservation area and be retained in such use in perpetuity unless as otherwise provided and agreed to by the Redmond City Council, the Interagency Committee for Outdoor Recreation, and any affected federal agency.

Section 5. That this resolution become part of a formal application to the Interagency Committee for Outdoor Recreation.

Section 6. That the City of Redmond has provided appropriate opportunity for public comment on this application.
