**RESOLUTION NO. 888**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY  
OF REDMOND, WASHINGTON, ESTABLISHING CARNIVAL,  
CIRCUS AND AMUSEMENT ACTIVITY FEES.

---

WHEREAS, the City Council, by passage of Resolution No. 793 of the City of Redmond, adopted an official fee schedule for administrative fees, and

WHEREAS, based upon a review of the current carnival, circus and amusement activity code adopted in 1938, the City Clerk has recommended that the Redmond Municipal Code (RMC) should be amended in order to update fees and to incorporate clean-up deposit charges and liability coverage requirements, NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

Section 1. Resolution No. 793, TITLE 5 - Business Licenses and Regulations of the City's schedule of LICENSE, PERMIT, INSPECTION PROCESS AND REVIEW FEES, attached hereto as Exhibit A, is hereby amended by changing the Municipal Code number references for carnivals, circuses and amusement activities to RMC 5.28.050.

Section 2. Resolution No. 793 is hereby further amended by adding a new Municipal Code number reference of 5.28.060, establishing the fee for a clean-up deposit of \$500 cash.

Section 3. Resolution No. 793 is hereby further amended by adding a new Municipal Code number reference of 5.28.080,

establishing a non-refundable application fee when an application for a license is denied of \$25.
