RESOLUTION NO. 925

A RESOLUTION OF THE CITY COUNCIL OF REDMOND, WASHINGTON APPROVING MEMBERSHIP TO THE CITIZEN ADVISORY BOARD FOR ARCH (A REGIONAL COALITION FOR HOUSING), AS RECOMMENDED TO THE CITY COUNCIL BY THE EXECUTIVE BOARD OF ARCH.

WHEREAS, Eastside communities share a common goal of ensuring the availability of housing that meets the needs of all income levels; and

WHEREAS, the jurisdictions of Redmond, Bellevue, Kirkland, and King County have created a regional planning entity called ARCH (A Regional Coalition For Housing) whose primary purpose is to plan for the housing needs of all Eastside residents; and

WHEREAS, citizen input and review is an important and necessary part of any regional planning effort; and

WHEREAS, the interlocal agreement adopted by ARCH participating jurisdictions calls for the creation of a citizen advisory board of 12 to 15 members to provide advice and recommendations to the ARCH Executive Board; and

WHEREAS, the Executive Board recommends that 12 members be approved by participating jurisdictions to serve on the ARCH Citizen Advisory Board; now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON HEREBY RESOLVES AS FOLLOWS:

That the membership of the Citizen Advisory Board for ARCH be approved as recommended to the City Council by the ARCH
