RESOLUTION NO. 973

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, AMENDING THE SCHEDULE OF FEES ADOPTED BY RESOLUTION NO. 793 IN ORDER TO REVISE CHARGES FOR USE OF THE REDMOND SENIOR CENTER AND GENERAL PARK FEES.

WHEREAS, Section 1 of Resolution No. 793, passed by the City Council on April 4, 1989, as amended, establishes a schedule of fees and charges for the usage of the Redmond Senior Center Building and for general park use, and

WHEREAS, the City Council, upon recommendation of the Parks Department, has determined to revise the fees and charges as set forth hereinafter, now, therefore,


THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

Section 1. Senior Center and General Park User Fees.

That portion of the schedule of fees and charges adopted by Resolution No. 793, as previously amended, and which relate to usage of the Redmond Senior Center and general park use, is hereby amended to read as set forth on Attachment 1 to this ordinance and incorporated herein by this reference as if set forth in full. The fees and charges set forth on Attachment 1 shall be effective commencing June 1, 1994. Such fees may be adjusted annually, as provided in Resolution No. 893 of the City.
