RESOLUTION NO. 977

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, SETTING THE DATE, TIME AND PLACE FOR A PUBLIC HEARING ON THE FINAL ASSESSMENT ROLL FOR LOCAL IMPROVEMENT DISTRICT NO. 89-ST-54 (LEARY WAY IMPROVEMENTS).

WHEREAS, the assessment roll for local improvements to Leary Way in connection with Local Improvement District No. 89-ST-54 has been prepared and filed with the City Clerk as provided by law; now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

Section 1. Hearing Set. The date, time and place for a public hearing to be held to consider recommendations, objections and other comments in connection with confirming the final assessment roll for Local Improvement District No. 89-ST-54 (Leary Way Improvements) shall be the 17th day of August, 1994, at 9:00 a.m. before the Redmond Hearing Examiner in the City Council Chambers of the Redmond Public Safety Building, 8670 N.E. 160th Street, Redmond, Washington.


Section 2. Objections. All persons who may desire to object to the assessments imposed upon their property are hereby directed to make their objections in writing, and to file them with the City Clerk at or prior to the date fixed for the hearing, and

to appear at the hearing and present testimony and other evidence. Written objections must clearly state the grounds of objection, and contain lot, block, section, tax or other numbers or identifying description. THE OBJECTIONS OF ANY PERSON WHO FAILS TO FILE AN OBJECTION IN WRITING AND PRESENT SUCH OBJECTION AS DIRECTED ABOVE WILL BE CONCLUSIVELY PRESUMED TO HAVE BEEN WAIVED AND THE HEARING EXAMINER WILL NOT CONSIDER SUCH OBJECTIONS.

Section 3. Notice. The City Clerk shall cause appropriate notices to be published and mailed to affected property owners pursuant to Section 35.44.090 of the Revised Code of Washington.
