

ORDINANCE NO. 1018

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING THE 1981 BUDGET ADOPTED BY ORDINANCE NO. 955, PASSED BY THE CITY COUNCIL ON DECEMBER 16, 1980, AS PREVIOUSLY AMENDED, TO ALLOCATE UNANTICIPATED REVENUE; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, at the time of adoption of the 1981 budget the amounts of revenues to be collected from various sources could only be estimated resulting in the need to supplement the budget to provide for allocation of unanticipated revenues, and

WHEREAS, the City has received unanticipated revenues from Equipment Rental Fund interest earnings and is in need of an additional appropriation to pay expenses properly charged to the Equipment Rental Fund, now, therefore

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. The final budget for the fiscal year 1981, as adopted by Ordinance No. 955, passed by the City Council on December 16, 1980, as amended by Ordinance No. 983, passed on May 19, 1981, further amended by Ordinance No. 987, passed on July 7, 1981, and further amended by Ordinance No. 994, passed on September 15, 1981, is hereby further amended by increasing the revenues to the Equipment Rental Fund No. 501 by the sum of \$15,000 from unanticipated income and appropriating said sum for the purpose of meeting unanticipated equipment rental expenses.

Section 2. Section 2 of Ordinance No. 955, passed by the City Council on December 16, 1980, as amended, is hereby further amended by revising the summary of totals of estimated revenues and appropriations incorporated in said section as Exhibit A to reflect the increases in revenues

and appropriation set forth in Section 1 of this ordinance.

Section 3. The Treasurer/Comptroller is hereby authorized and instructed to effectuate the necessary changes to the 1981 budget and to make all necessary and appropriate line item entries and adjustments in order to reflect the increases to revenues and appropriation of funds as set forth in this ordinance.

Section 4. This ordinance shall be in full force and effect five days after passage and publication by posting as provided by law.


