AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, AMENDING THE PERSONNEL ADMINISTRATION MANUAL, 1974 EDITION, APPENDIX IV, BY ADDING CERTAIN CLASSIFICATIONS TO PAY PLAN B-1, DELETING CERTAIN CLASSIFICATION TITLES FROM PAY PLAN C, ADDING CERTAIN CLASSIFICATION TITLES TO PAY PLAN E. ESTABLISHING A NEW PAY PLAN PN/R FOR PERMANENT NON-REGULAR EMPLOYEES, SETTING PAYROLL CATEGORIES FOR SAID CLASSIFICATIONS AND ESTABLISHING AN EFFECTIVE DATE.

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. The Personnel Administration Manual, 1974 Edition, Appendix IV-7B, is hereby amended to delete the classification of Police Office Assistant III from Pay Plan C, as set forth in Exhibit B, attached hereto and incorporated herein by this reference as if set forth in full.

Section 2. The Personnel Administration Manual, 1974 Edition, Appendix IV-10, is hereby amended to revise the Index of Position Titles by pay grade for Pay Plan E by adding the classifications of Director, Citizen Service Bureau and Crime and Evidence Technician and as set forth in Exhibit C, attached hereto and incorporated herein by this reference as if set forth in full.

Section 3. The Personnel Administration Manual, 1974 Edition, is hereby amended to add Appendix IV-12, Index of Classification Titles by Pay Grade for Pay Plan PN/R as set forth in Exhibit D, attached hereto and incorporated herein by this reference as if set forth in full.
