

ORDINANCE NO. 1127

AN ORDINANCE OF THE CITY OF REDMOND, WASHINGTON, RELATING TO FLOOD CONTROL, AMENDING CHAPTER 15.04 OF THE REDMOND MUNICIPAL CODE TO REQUIRE THAT DEVELOPMENT WITHIN SAMMAMISH FLOOD CONTROL ZONE NO. 4 COMPLY WITH THE STATE FLOOD CONTROL ZONE ACT AND REGULATIONS.

WHEREAS, in order to expedite issuance of permits for construction within areas of the City subject to flood control requirements the City requested that the Washington State Department of Ecology delegate the administration of the Flood Control Zone Permit Program to the City of Redmond, and

WHEREAS, pursuant to Department of Ecology Order No. DE 83-181, dated March 29, 1983, administration of such program has been delegated to the City of Redmond, provided that the City's ordinances governing flood control be clarified to require compliance with state statutes and regulations in the case of development within Sammamish Flood Control Zone No. 4, now, therefore,

THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Chapter 15.04 of the Redmond Municipal Code, the codification of Redmond City Ordinance No. 863, passed by the City Council on February 20, 1979, is hereby amended by adding a new Section 15.04.045 thereto to read as follows:

15.04.045 Compliance With State Flood Control Zone Permit Program Required - Administration by City.
Pursuant to delegation of authority by the Washington State Department of Ecology, the City of Redmond is charged with the responsibility of administering the Washington State Flood Control Zone Permit Program within the City. All development within the boundaries of Sammamish Flood Control Zone No. 4, the boundaries of which are set forth on the official Division of Hydraulics Map maintained within the Public Works Department of the City, shall comply with Chapter 86.16 of the Revised Code of Washington, the State Flood Control Zone Act, and Chapter 508-60 of the Washington Administrative Code, the Permit Program Regulations.

Section 2. This ordinance, being an exercise of a power specifically delegated to the City legislative body, is not subject to referendum, and shall take effect five (5) days after its passage and publication by posting as provided by law.


